

## 2.4.接触材料及制品检测 Testing of Contact Materials and Products

## 2.6.保质期专项服务 Special Service for Shelf Life

产品保质期是指产品在标明的贮存条件下保持品质的期限。有的宠物食品虽然在保质期内,但随着时间的推移,受生物、化学、物理等方面因素的影响,部分产品可能会出现油脂氧化、微生物滋生等问题,影响宠物健康。

Product shelf life refers to the period during which product maintains quality under indicated storage conditions. Although some pet foods are within the shelf life, as time goes by, affected by biological, chemical, physical and other factors, some products may suffer from oil oxidation, microbial growth and other problems, affecting pet health.


